Principle and scope This data

Processed data We

attach great importance to the protection of your personal data. When you use our website and services, we primarily process the data necessary for use that you transmit to us and the information we collect directly (see below).

If you have provided us with your email address or have contacted us directly by email, we may also send you information by email that is related to processing your concerns and questions.

The legal basis for processing your data is based on our legitimate interest in being able to process your online request efficiently and effectively. If the aim of the email contact is to conclude a contract, data processing is based on the initiation of this contractual relationship.

reCAPTCHA

To ensure that the form(s) on our website are filled out by a human and not a bot, we use reCAPTCHA. reCAPTCHA is provided by Google LLC (1600 Amphitheater Parkway, Mountain View, CA 94043, USA). Google's privacy policy can be accessed at the following URL: policies.google.com/privacy

Google Analytics

IP anonymization

SSL
